## 8.2 Northcote Road/ Old Langho Rd

Highways officers have considered the request for the junction of Northcote Road and Old Langho Road but as this junction has a good safety record with no collisions resulting in injury

and no indication that vehicles fail to give way to traffic that has priority in this location. This area does not qualify for a stop sign. The re-painting of the road markings will be undertaken.

8.3 FP 35, RVBC have acknowledged the PC's concerns and are looking into it, PRW122462, this is the footpath near the community centre.

8.4 Elker Lane parking Cllr Austin commented "Following my recent visit to Chris Quinn and the development, I share the concern of others, regarding the poor and very limited sight lines towards Brockhall, when exiting the junction from the Meadows unadopted road. I have asked the Planning Department at Ribble Valley to check whether the junction is as specified on the plans (application. 3/2016/0927) particularly as regards the vision splays I would certainly be willing also to attend a meeting with residents, if one is arranged."

Cllr Schofield commented "May I add on the subject, as Mr Wright the Headteacher of St Augustine's high school had apparently previously suggested, the Elker Meadows' residents (or alternatively the developer St Vincent's housing association with whatever ongoing responsibility) should consider erecting a sign at the entrance to Elker Meadows indicating that it is a private road (in addition to the existing sign(s) farther in)."

8.5 Concerns were raised about vehicles traveling at high speed on Elker Lane, and the limited sight line at the junction – members of the parish council are to do a site visit.
